Your doctor has recommended Praluent[®] to help you manage your cholesterol. This fact sheet explains how the **Praluent**[®] **PFP** works and what additional support is available.

ABOUT PRALUENT[®]

Praluent[®] is a cold-chain (requires refrigeration) medicine that helps your liver remove 'bad' cholesterol (low density lipoprotein cholesterol, LDL-C) from your blood. It is used together with diet, exercise and other cholesterol-lowering medications and injected under the skin using a pre-filled pen every two or four weeks as directed by your doctor.

ABOUT THE PRALUENT[®] **PFP**

This Program is Sponsored by Sanofi, the manufacturer of Praluent, and managed by Pharmacy Phusion.

Eligible patients participating in this Program will be able to access Praluent free of charge. The duration of the program will be approximately 6 months and is subject to change should there be amendments to the Pharmaceutical Benefits Scheme (PBS) reimbursement criteria. You will also benefit from access to a team of dedicated Program pharmacists.

Your doctor will supply you with a prescription for Praluent and send a copy to the Program Pharmacist Team.

The Pharmacist Team will contact you directly to organise your supply. You will need to nominate a local pharmacy where Praluent will be delivered.

Your Nominated Pharmacy will contact you once they have received your delivery of Praluent.

4



Visit your Nominated Pharmacy with your prescription to collect Praluent.
